## Animal Behaviour and Enrichment Facilitator – Full Time

- Shift consists of one weekend day from 9:00 AM to 5:30 PM and 4 weekdays from 10:30 AM to 7:00 PM 37.5 hours per week
- Annual Salary of \$33,150.00

Reporting to the Team Lead of Behaviour, Calgary Humane Society Behaviour & Enrichment Facilitators are responsible for providing behaviour and enrichment support to the animals in our care as well as creating custom training and enrichment plans for staff members, volunteers, and foster parents to implement.

### Specific responsibilities include, but are not limited to:

- Act as a handler and/or observer during medical exams using journaling methods;
- Determine placement and pathway options for animals based on all information gathered;
- Positive reinforcement of preferential behaviors as well as teaching foundational obedience and building relationships with animals;
- Provide an accurate interpretation of animal body language, stress levels, and emotional states and create and facilitate appropriate stress reduction and enrichment plans to be implemented by staff, volunteers, and foster parents;
- Observe, document, and communicate current and potential behaviour of CHS animals to staff and members of the public, including potential adopters and foster parents;
- In conjunction with the Manager of Animal Operations, monitor the animal wait lists and recommend animals that should be scheduled for intake based on available resources;
- Interview owners who are surrendering their animals to gain an understanding of the animal's behavioral history;
- Provide enrichment to individual animals to enhance their quality of life while in the shelter;





- Ensure human safety during animal interactions by recognizing stress and in animals and enforcing appropriate handling techniques amongst staff, volunteers, adopters, and communicating the animal's behavior effectively to all parties;
- Respond to email and telephone inquiries from the public to CHS' behaviour helpline;
- Document the animal's behavior history, observations, and recommendations for foster parents and adopters in CHS' shelter database;
- Provide support for volunteers and foster parents with managing observed behavior concerns;
- Create and provide presentations to staff, volunteers, and foster parents on animal behavior topics including necessary training for staff and volunteers to recognize, report, and understand animal behavior;
- Educate staff, volunteers, and foster parents on appropriate terminology with respect to animal behavior and body language;
- Provide training and support to CHS volunteers;
- Maintain accurate and complete program records and statistics;
- Develop, maintain, and update departmental materials and resources on an ongoing basis;
- Other related duties as assigned

- Demonstrated understanding of animal behavioral science and how to apply this knowledge humanely when developing and implementing training and enrichment plans;
- Training philosophies in line with CHS' position statements, and follow the least intrusive and minimally aversive (LIMA) principles;
- Ability to work well on a team by building and maintaining trusting, collaborative, and compassionate relationships;
- Ability to work independently when required;
- Ability to multi-task and adapt to changing priorities and organizational needs;
- Strong interpersonal skills and the ability to effectively communicate with a diverse team to accomplish common goals;
- Dependable and reliable in completing assigned tasks and meeting deadlines;
- Excellent organizational skills;
- Life-long learner with commitment to keeping up to date on developments in animal behaviour and animal welfare for continual improvement of best practices, policies, and procedures;
